LOL AUTUMN HAPPY HOUR



COMMUNITY SERVICE SPOTLIGHT: SOUTH ALABAMA VOLUNTEER LAWYERS PROGRAM



The South Alabama Volunteer Lawyers Program (SAVLP) is a 501(c)(3) nonprofit organization that provides free legal assistance in certain civil legal matters to low income residents of Baldwin, Clarke, Mobile, and Washington Counties through the service of over 885+ local volunteer attorneys.

- Estates (by agreement)
- Foreclosure Prevention
- Guardianship and conservatorship
- Landlord-Tenant matters
- Name changes (minor and adult)
- Paternity/legitimation (by agreement)
- Power of attorney
- Visitation
- Wage claims (under \$2500)
- Wills and living wills

Special Programs

Free Legal Advice Clinics

Volunteer lawyers working with SAVLP provide limited legal advice about certain civil legal matters such as landlord/tenant, wills and estates, consumer finance and family law. Limited legal advice gives you the ability to meet with an attorney for free limited scope advice (the attorney does not represent you after the clinic).

Community Economic Development Initiative

SAVLP attorneys provide assistance with the legal formation and establishment of non-profit organizations that would benefit low-income citizens and review contracts and commercial leases for non-profit entities.

Wills for Heroes

Wills for Heroes offers first responders free basic estate planning services. This service is intended to give them peace of mind by knowing that their affairs are "in order" should the unthinkable occur. SAVLP manages the Mobile, Baldwin, Clarke and Washington County administration of the project.



To be eligible you must live in Baldwin, Clarke, Mobile, or Washington counties or have a legal matter that must be handled in Baldwin, Clarke, Mobile, or Washington County. You must be 19 years or older. A parent or legal guardian can apply for services on behalf of a minor in some circumstances. This is an income and asset based program for low-income households. Your income and assets must fall beneath a certain level.

The kinds of cases *normally accepted are:

- Adoption (by agreement)
- Advice before lawsuit
- Custody (by agreement)
- Child support modifications
- Collection of judgments (under \$3000)
- Contracts and warranties
- Credit access and debt collection
- Deeds and home ownership issues
- Divorce (by agreement or by publication)
- Enforcement of court order from divorce involving children (excluding child support)
- Enforcement of worker's compensation (under \$1000 or for medical expenses)

2018 VETERANS DAY PARADE
